

The Lessee shall, at his/her expense provide the horse/pony with proper food, stabling, hoof call and paddocking and shall do all that is reasonably necessary to keep the horse/pony in sound heal and condition, including the provision as required, of all necessary veterinary treatment by veterinary surgeon of his/her choice. The Lessee shall notify the Lessor of any major illness injury to the horse/pony.					
5.	The Lessee shall not assign his/her interest in the horse/pony under this agreement or lend or pawith the possession of the animal without the consent of the Lessor being first obtained.					
6.	The Lessee acknowledges having inspected and ridden the horse/pony and that he/she has relieupon his/her own judgement in deciding to lease the horse/pony from the Lessor and that the Less shall be under no liability to the Lessee for any injury loss or damage suffered by the Lessee cause by the horse/pony whether being ridden by the Lessee or not.					
7.	At the expiry of the lease, the Lessee will deliver the horse/pony back to the Lessor.
